Dear Director Frakes:

This letter is confirmation of previous communications with you on June 18, 2015 and Associate Legal Counsel Mark Boyer on June 22, 2015 regarding the proposed importation of sodium thiopental. As you know, the Drug Enforcement Administration (DEA) was notified by the Food and Drug Administration (FDA) that the sodium thiopental the Nebraska Department of Correctional Services seeks to import is an unapproved drug product in the United States and it appears to be misbranded or in violation of 21 U.S.C. § 355. According to the FDA, there is no approved application for sodium thiopental, and it is illegal to import an unapproved new drug into the United States.

In light of the information provided by the FDA and the Nebraska Department of Correctional Services' recently submitted the DEA Controlled Substances Import/Export Declaration, DEA Form 236 (Transaction ID 5159973), the DEA notified the Customs Border and Protection and the FDA of the potential illegal importation of sodium thiopental.


