FACT SHEET

Let the DREAMers DREAM

The DACA (Defered Action for Childhood Arrivals) program allows certain undocumented immigrant youth who came here as children – commonly known as DREAMers because of the proposed DREAM Act federal legislation – to live

and work in the United Sates for a renewable period of two years without fear of deportation.

Nebraska Governor Dave Heineman said in a press statement on August 17, 2012 that he would deny driver's licenses to immigrants who participate in this program.

This discriminatory and anti-immigrant stance would have an impact on young people who have called Nebraska home and want to contribute to our economy and communities.

The ACLU has already filed lawsuits in Arizona and Michigan, whose governors are also pushing discriminatory, anti-immigrant policies. In Nebraska, the ACLU will be filing a lawsuit. There are three primary reasons for the lawsuit:

Denying young Americans the ability to drive is unlawful

Denying driver's licenses to DREAMers is a violation of both state and federal law. The Obama Administration has given DREAMers "lawful status" which obligates the state of Nebraska to provide for identification, such as driver's licenses. Additionally, the governor does not have the authority to make this decision on his own. He has stepped into a realm that should be governed by the Legislature.

Denying young Americans the ability to drive is poor policy

Recent studies confirm that immigrants are a boost to Nebraska's economy. The ACLU has been working with hundreds of talented young people who want to contribute to the American economy and provide for their families. The governor's order would impact

daily life, such as going to the grocery story, attending church, and finding and keeping a job. Issuing licenses will also promote public safety by decreasing the risk of accidents caused by unlicensed drivers and enlarging the pool of insured.

Denying young Americans the ability to drive is unAmerican

The majority of Nebraskans (58%) believe that undocumented immigrants who are working should be able to keep their jobs and pursue legal status. Governor Dave Heineman has consistently

pushed anti-immigrant policies, even when diverse groups such as the Nebraska Catholic Conference, law enforcement officials, educators, and a variety of human service organizations have expressed concerns.

Immigration & the ACLU

The ACLU began it's immigration work in the 1920s. Since then, affiliates like ours have taken on discriminatory, antimmigrant policies in the courts and legislatures around the country. Here are some highlights of our work in Nebraska.

■ Martinez v. Fremont The City of Fremont passed a discriminatory anti-immigrant housing ordinance in June 2010 and a federal court struck down most of the law in 2012. The ACLU appeared before the 8th Circuit Court of Appeals in December 2012 to further

■ Claudia Leiva-Deras Claudia was raped while in an immigration detention center. It took the ACLU's intervention for her to receive proper medical care. She is now a legal permanent resident who works with other immigrant women.

cement the victory.

■ Defeating Anti-Immigrant Legislation

The ACLU has mobilized supporters to defeat "show me your papers" laws such as voter ID, and AZ-style bill, and attacks on education for children of immigrants.
