I sent you one request already, explaining a little bit about my situation and you said you would try to see if I'm eligible for a custody override. Due to the fact that my son's mother passed away in the Douglas County Jail 2 months ago and because of a couple of issues, including my diagnosis for cancer back in June I was wondering if I could be given an override for work release. I don't have any violence on my record and I've maintained a good institutional record also. I see the parole board in February also. Due to the incident I've had previously this past year, I was forced on constant monitoring with someone at MSP and also TSCI. Could you please let me know if it's possible to be given an override for work release. I used to have a pending case in Sarpy County, but it was dismissed two weeks ago. I'm not sure if I need to be on protective custody.

Thank you for your time and effort. I'm worried about getting Scott back to MSP, where I was assaulted this past year. Could you please make sure I'm not sent back there? The threat group who assaulted me are still there.

MESSAGE: LAST THURSDAY I WAS INVOLVED IN AN ALTERCATION AT MSP. I

WAS ASSAULTED FROM BEHIND AND WAS HOSPITALIZED IMMEDIATELY FOLLOWING THE INCIDENT.
HOWEVER, I WAS TRANSPORTED HERE TO THE HOSPITAL AT DEC, DUE TO THE EXTENT
OF MY INJURIES (I AM IN A NECK BRACE, SUSTAINED A SERIOUS CONCUSSION) BECAUSE OF
NECKPAIN LOSS AND OTHER SERIOUS ISSUES, I WILL BE HAVING TO SEE A SPECIALIST.

I HAVE SEVERAL CONCERNS. FIRST, I AM ON IS STATUS, PENDING MY IAR HEARING. THEREFORE
I AM ONLY LIMITED TO ONE PHONE CALL PER WEEK, CONFINED TO MY CELL, ABOUT 2 1/2 ALCOHOLS
PER DAY. I SENT SEVERAL REQUESTS (AND I HAVE MY COPIES) TO BOTH THE ASST. WARDEN RINE,
AND ALSO MR. RANDOLPH EXPLAINING THAT BECAUSE OF PROBLEMS I HAD AT MSP LAST YEAR (
~~WHICH I WAS ALSO ASSAULTED THERE~~) I ASKED TO NOT BE SENT THERE WHEN I
STILL ENDED UP BEING SENT THERE AND NOW, I HAVE SERIOUS MEDICAL TREATMENTS. I HAVEN'T
HAD A CHANCE TO LET MY WIFE KNOW I AM HERE ALSO, ON THE SAME DAY LAST THURSDAY AS SOON
I WAS TAKEN TO THE HOSPITAL, ALL MY CANTREEN WERE SEIZEN AND I HAD JUST SPENT \$800.00 THAT
MORNING. NOW BECAUSE I AM IN THE HOSPITAL HERE, I DON'T KNOW WHAT'S GOING TO HAPPEN. I AM
NOT TO BE SENT TO MSP BECAUSE I WAS WORRIED SOMETHING LIKE THIS WAS GOING TO HAPPEN

IF I WAS SENT TO MSP WITH WORKS FOR THE CHANNEL 7 NEWS IN OMAHA TO CONTACT MY CASE AND ASK ME
