## **Victory for Family Planning Funding**

Health care providers and patients rally with the ACLU during the 2017 legislative session

- Over 14,500 rural and low-income Nebraskans rely upon health centers that receive federal Title X family planning funds for well woman exams, lifesaving cancer screenings, STI testing and treatment, and birth control.
- Many Title X health centers are the only provider for low-income women in rural Nebraska communities.
- Over 1,000 Nebraskans made phone calls and over 250 emails were sent to lawmakers in less than two weeks.

In an effort to defund Planned Parenthood, lawmakers in Nebraska attempted to change the formula for how Nebraska distributes federal Title X family planning funds. This was another blatant attempt to put politics before patients in Nebraska. Thousands of Nebraskans saw through the sneak attempt and together we sent thousands of messages to the Unicameral in just two weeks. While the proposal was stopped this session, lawmakers have made it clear they want to try again in 2018. We hope you will stand with family planning patients like Mia and thousands of other Nebraska women again.

## PEOPLE POWER IS THE ROCKET FUEL FOR RESISTANCE & PROGRESS

At the dawn of this new political reality, our goals must be both resistance and progress. When I feel heartsick for my Nebraska neighbors caught in the crosshairs of Trump/ Ricketts rhetoric and policies, I stiffen my resolve to use my time, talent, and every fiber of my being to fight back. Today, I have hope and I remain optimistic because of the ACLU and because of you. People Power activists like you have stepped forward from Omaha to Lincoln to Fremont and beyond to ensure that our refugee and immigrant neighbors are not profiled or discriminated against. Scores of lawyers have volunteered as legal first responders, ready to help out if a raid happens in one of our communities. Recently, a new supporter stopped me in the grocery store to thank us for our work and showed me their ACLU pocket Constitution.

The ACLU of Nebraska-fueled by your activism-is making a positive difference. For example, in 2017 a diverse coalition and countless grassroots activists like you beat back a discriminatory Voter ID law for the 6th year straight. We established first ever protections for pregnant and parenting students in our schools to ensure no person has to choose between finishing their education and taking care of their family. Our historic victory at the Nebraska Supreme Court striking down the ban on LGBT foster parents has opened scores of safe homes and warm hearts to some of Nebraska's most vulnerable children. These are ACLU People Power victories!

People who have never before engaged with the ACLU are stepping forward to fight back. Long time loyal ACLU supporters are deepening their investment and renewing their activism. Even with our list of members, supporters and activists tripling to over 20,000 supporters, the ACLU of Nebraska is still the David to the Trump/Ricketts Goliath. Nationally our team of 300 litigators is up against 11,000 at the Department of Justice. Locally our small but mighty 6-person staff is up against 100+ staff at the Nebraska Attorney General's office and scores of government lawyers across Nebraska. Our Attorney General has sadly decided to score political points by attacking transgender youth and young Dreamers. Our Secretary of State might turn over sensitive information about voters to a sham Presidential Commission. Local city attorneys are still bringing criminal charges against those experiencing homelessness when they peacefully ask their neighbors for help. We have a lot of work to do. But we can and we will win by working together.

I renew my promise to you—we will never stop fighting until the rights of all Nebraskans are respected by all Nebraskans. Working together we can and we will do just that. Power to the people!






# SHAPING CIVIL LIBERTIES FOR GENERATIONS TO COME

Nathan Calvin, Grinnell College, heads into the Nebraska State Capitol to discuss his work with State Senator John McCollister. Each year, dozens of undergraduate interns and law clerks join our ranks to hone their skills as the next generation of civil rights leaders. They don't just make copies or fetch coffee. They make a difference on the front lines of Nebraska's most pressing civil rights and civil liberties issues.

#### The First Amendment & Asking for Help

I am researching panhandling ordinances to ensure Nebraska cities understand how to reform their ordinances to respect free speech rights. The First Amendment protects freedom of speech and that includes asking people for help. For an ordinance to be constitutional, there can only be very narrow limits on this protected free speech. Recently, the Omaha City Council changed the panhandling ordinance (with help from the ACLU) and it has kept hundreds out of debtor's prisons. I have hope that my research will support these kinds of changes in Lincoln so the City Council updates our local laws to stop criminalizing those who are engaged in peaceful free speech.

#### Meeting Our Transgender Neighbors

Growing up in rural Nebraska, I know there is a strong sense of community. This summer I traveled to three Nebraska communities with Ashlev Swartz, a transgender Nebraskan, as she shared her story of growing up and living in Malmo, NE. During these events, it was the audience questions that gave me the most hope. In North Platte, an educator asked how to show that her classroom is a safe place for all students. In Scottsbluff, religious leaders gathered to discuss inclusion for our transgender neighbors in their congregations. In McCook, individuals sought support for friends and loved ones. Nebraska still has a long way to go to secure basic rights and full equality for our transgender neighbors but seeing Nebraskans like Ashley sharing her story to change hearts and minds for lasting change gives me hope.

#### \$1.00 A Minute: For-Profit Jail Calls

I served an open records request to all 68 county jails to investigate how those who are incarcerated can stay in contact with friends, families and their attorneys. I was shocked at how much families were paying to stay in contact – \$19 for a 15-minute call was not out of the ordinary! Private companies and jails in Nebraska are openly profiting off the families of the incarcerated. I presented our findings to State Senator John McCollister who is taking the lead on this issue. My research will result in a first of its kind report on this issue in the fall of 2017. While it is easy to get caught up in all the many ways that government is dysfunctional, working on this project has given me hope that committed organizations can successfully work with legislators across the political spectrum to solve pressing problems.
