### **NEBRASKA PRISON SYSTEM IN CRISIS**

Conditions Cross into Unconstitutional Territory

The ACLU of Nebraska has taken the lead in investigating constitutional violations in Nebraska's prison system while advocating for practical solutions that use our resources wisely. Our ground breaking reports are frequently cited by policymakers. To learn more please visit aclunebraska.org/prison\_reports.

This fall we welcomed David Fathi, Director of the ACLU National Prison Project to Nebraska to raise awareness about growing constitutional violations in our dysfunctional prison system.

David shared these shocking statistics:

- Nebraska spends thousands of dollars more per inmate than many other states.
- Nebraska inmates are in solitary confinement at a rate over twice the national average.
- Nebraska puts more people behind bars for marijuana use, per capita, behind only New York and Washington D.C.

In December 2014, we filed a lawsuit on behalf of Joshua Franklin who, like half of those behind bars in Nebraska, is serving time for non-violent offenses. Joshua was assaulted multiple times by other inmates and despite his written pleas to prison officials, nothing was done to keep him safe. These assaults led to a series of serious injuries. We believe Nebraska's prison overcrowding crisis is a factor in this and other cases.

If policy makers do not heed the ACLU's warnings, we are prepared to file additional lawsuits challenging Nebraska's prison system.

Per capita, Nebraska sends more people to prison for marijuana than anywhere else in the US except New York and Washington D.C.

Extreme sentencing laws and mandatory minimum laws strip judges of their ability to make the sentence actually fit the crime.

#### **ELIMINATE UNNECESSARY INCARCERATION.**

Roughly half of Nebraska's inmates are behind bars for nonviolent offenses.

Problems like mental illness. substance abuse, and homelessness should be addressed as public health issues —not criminal justice.

### PROTECTING THE RIGHTS OF NEW IMMIGRANTS

In December 2014 the Omaha World Herald published poll results that showed a clear majority of Nebraksans (63%) support common sense immigration reform. However, that broad public support is frequently undermined by some political leaders and law enforcement officials who fail to respect the constitutional rights of new immigrants.

To help the ACLU of Nebraska work more effectively with new immigrants, a generous donor supported the hiring of Guillermo Guzmán as a community organizer based out of Omaha. Guillermo moved to the United States from Mexico when he was a teenager and is a recent graduate of Creighton Law School.

With Guillermo's legal expertise and community connections, we are providing better outreach to new immigrant communities, providing more Know Your Rights trainings to Spanish-speaking audiences, and expanding our efforts to bring impact litigation and policy solutions to ensure justice for new immigrants.
