NOTICE OF APPEAL TO THE SUPREME COURT

Plaintiffs Planned Parenthood of the Heartland and Sarah Traxler by and through their attorneys pursuant to Neb. Ct. R. App. P. § 2-101 hereby provides notice of their intent to appeal the final order and judgment entered on August 11, 2023, and all other orders of the Court that merged into the final order and judgment granting Defendants' Motion to Dismiss and overruling Plaintiffs' Motion for Summary Judgment and finding that L.B. 574 does not violate the single-subject rule of the Nebraska Constitution of Article III, Section 14.

Plaintiffs seek appeal to the Supreme Court of Nebraska as the above-captioned civil case matter involves the constitutionality of a statute. Neb. Ct. R. App. P. § 2–101(B)(1)(a); Neb. Rev. Stat. § 24-1106(1). Plaintiffs allege that L.B. 574, as passed by the 108th Nebraska Legislature and signed into law on May 22, 2023, violates Article III, Section 14 of the Nebraska Constitution, which instructs that "[n]o bill shall contain more than one subject."
